I was born in Athens in the year 1956. I graduated from the College of Athens in June 1975.

In October of the same year, after the successful completion of the prescribed exams, I was admitted to the School of Law of the University of Athens (Department of Law). During my studies, owning to my high grades in the department's exams, I was awarded honorary titles of scholarship from the Institute of State Scholarships (IKY). During my studies in the School of Law, I participated in most of the tutorial courses. In the context of Civil Law lectures, I wrote an essay concerning fictitiousness in

Civil Law, whereas in the context of Ecclesiastic Law lectures I wrote an essay concerning the relations between the Church and the State during the period of Persecutions. In April 1980, I was awarded the University Degree of Law with GPA: Excellent – Distinction (9 & 1/8) and I was ranked 1st among the other graduates.

After the award of my degree, in September 1980, I was registered at the University of Long (King's College) for postgraduate studies in Commercial Law and the Law of the European Communities. More specifically, I attended the following courses: Law of European Institutions, Law of European Competition, Law of European Community, Law of Human Rights and Fundamental Rights. During my studies I participated in the organized seminars and I presented the projects "The Extra Territorial Jurisdiction of the EEC", in the context of competition and "The action against Member States under the Art.169 of the EEC Treaty", in the context of the course of European Institutions Law. In November 1981 I was awarded the Diploma MASTER (LL.M). For my studies in London I was awarded the honorary scholarship of Onassis Foundation.

In October 1983, I started collecting the relevant legislation and literature, in the context of writing my PhD dissertation with the topic "Know-how Concession in the Community Legal Order of Competition" under the supervision of the late Professor of Labour Law Alkis Argydiadis.

The processing of the legislation and the completion of the relevant material gathering was elaborated in the Institute of Advanced Legal Studies of the University of London, of which I became a member in June 1982. I lived in London from July 1984 until March 1985, where, under the supervision of the Professors Mr. Fr. Jacobs and Mr. Val. Korah, I wrote my PhD dissertation. The writing was completed in the Study area of the Commercial and Maritime Law of the University of Athens. The project was submitted as a PhD dissertation to the Department of Law of the School of Law, Economic and Political Sciences of the University of Athens, after the proposal of the professors of Commercial Law Alkis Argyriadis, Leonidas Georgakopoulos and Mr. Nikolaos Rokas, members of the Three Member Introductive Committee and the professors Mr. Th. Liakopoulos and Mr. E. Perakis, which together with the prementioned professors constituted the committee. In December 1986, I was nominated as Doctor of the School of Law (PhD) of the University of Athens with GPA "Excellent – Distinction". My dissertation was published in 1987 by the publishing

firm Antonis N. Sakkoulas in the series "Studies of Commercial and Maritime Law" (volume 10).

III. Professional Activity

After the award of the postgraduate diploma MASTER, I worked as a trainee attorney in an attorney's firm in Athens, for approximately one year. In October 1982 I was employed as attorney in the Court of First Instance of Athens, after the successful completion of the exams of the Court of Appeals of Athens.

From 17/06/1983 until 31/08/1983 I worked for the EP's Directorate-General for Research and Documentation in the European Parliament in Luxembourg, being awarded the scholarship of Robert Shuman, in the field of research engagement for the protection of personal rights in EEC Member States.

On 23/03/1988 I was promoted to an Attorney of the Court of Appeals of Athens. As an attorney I was mainly occupied with Commercial and European Law cases, some of them before the Court of European Communities of Luxembourg. I resigned from the legal profession on 07/03/2016 and I was nominated as Honorary Attorney of Athens, by means of decision of the Board of Directors of the Athens Bar Association, after practicing law for 35 years and 6 months.

From 01/09/1994 until 13/06/1997 I worked as an hourly rate paid Professor at the IST Studies College, teaching Commercial and European Law. The curriculum and modules schedules were determined pursuant to the program of studies of the British University of Hertfordshire.

From September 1995 until September 1998 I was President of the scientific group "European Expression".

By means of the Ministerial Decision no: E5/353/26.03.1998 published at the Government's Official Gazette (G.O.G) no:85/vol.P.L.E/15.05.1998, I was employed as Scientific Personnel – Professor, with cognitive field "Law specialized in Commercial Law – Law of Competition" of the Department of Business Administration of the School of Management and Economics of the Technological Educational Institute of Chalkida, where I was teaching until 20/03/2000 the courses of Commercial Law and European Law. At the aforesaid date I resigned due to my candidature as Member for the elective region of the County of Karditsa in the forthcoming elections in April 2000.

Pursuant to the deed no: 1665/17.03.2015 of the Chairman of the Technological Educational Institute of Central Greece, published at the Government's Official

Gazette no: 471/vol.C/19.05.2015, I ex officio returned in a personal post of Associate Professor of the Department of Business Administration of the School of Management and Economics of the T.E.I of Central Greece, since 05/02/2015.

By means of decision of the Chairman of the T.E.I of Central Greece, on 12/09/2016 I was assigned the duties of the President of the Department of Business Administration, of the School of Managements and Economics of the T.E.I of Central Greece.

Pursuant to the deed no: 822/10.02.2017 of the Chairman of the T.E.I of Central Greece, published at the G.O.G 147/vol.C/17.02.2017 I was transferred from the Department of Business Administration to the Department of Accounting and Finance of the same School of the T.E.I of Central Greece, in the same step and specialty, where I am teaching the courses of Civil, European and Commercial Law.
